OFFICE ORDER No.15 OF 2009.

Failure to assume charge of the post within 15 days shall be deemed as refusal of ad-hoc promotion. The charge assumption report of the officers may be sent to DGE&T(Hqrs.) immediately.

4. The ad-hoc promotion and posting of above said 22 Training Officers are against live posts of ADT.

5. The Controlling Officers in respect of these officers shall also intimate to the undersigned immediately whether the officers concerned have accepted the offer of ad-hoc promotion.
