

MINUTES

MINUTES OF THE MEETING OF THE SUB-COMMITTEE OF NATIONAL COUNCIL FOR VOCATIONAL TRAINING (NCVT) DEALING WITH AFFILIATION HELD ON 24th FEBRUARY 2012 AT 10.30 A.M. IN THE COMMITTEE ROOM, MINISTRY OF WATER RESOURCES , SHRAM SHAKTI BHAWAN, NEW DELHI.

Meeting of the Sub-Committee of NCVT dealing with affiliation was convened on 24th February, 2012 at 10.30 A.M. under the chairmanship of **Shri Sharda Prasad, Director General/Joint Secretary**. The details of members present in the meeting are at Annex 'A'.

At the outset, **Director General/Joint Secretary**, welcomed the members and informed that a total of 159 (132 +27 COE) affiliation proposals of Govt. and Private Institutes (ITIs) received from different States/UTs have been processed and put up to the Sub-Committee of NCVT for granting affiliation. DG/JS desired that affiliation proposal should be scrutinized uniformly on merit basis and no deviation from NCVT norms were allowed. As per agenda, the following was taken up:

Item No. 1: Confirmation of minutes of the Meeting held on 27th January 2012.

Members were informed that minutes of the last meeting were conveyed to all members. No inputs/suggestions were received for modification. The minutes of the last meeting held on 27th January 2012 were confirmed.

Item No. 2: The following points were discussed in the meeting.

1. The Sub-Committee members emphasized that State Govts. must conduct preliminary inspection in a professional and comprehensive manner as per latest syllabus and only after their satisfaction, recommend inspection by the Standing Committee.

2. It was decided that State Directors may forward the reply of the clarification cases along the required necessary papers duly attested/verified by the State Directorate immediately so that they could be considered in the next meeting.

3. It was also emphasized that officials of State Govt. and members of the Standing Committee must be held accountable to any lapse/inconsistency and action should be taken against the erring officials and members of the Committee.

DG/JS emphasized that high degree of professionalism and honesty be displayed by the committee members who carry out inspections like preliminary inspection/SCIR/DIR/SIR etc. and all concerned be instructed for such actions.

Item No. 3: Consideration of recommendations in respect of inspection reports received from States/UTs.

Sub-committee discussed 159 affiliation proposals of ITI/ITCs [28 Govt. + 104 Pvt. + 27 COE] received from various States/UTs and decided as follows:-

Proposals recommended w.e.f. February 2012 session	-	107
Proposals rejected	-	11 (04 Govt. +07 Pvt.)
Clarifications sought	-	14
New Institutes affiliated	-	32 (0 Govt. + 32 Pvt.)
COE affiliation proposals dealt	-	27

The meeting ended with a vote of thanks to the chair.
